COOKIE POLICY

This Cookie Policy (the "Policy") applies to all Users browsing and using the Joycee Gifts website (the "Website"), available at https://joycee.gifts. This Policy forms an integral part of the Website's Terms and Conditions and shall be read in conjunction with the Privacy Policy.

The Website uses cookies and similar technologies to store and retrieve information on the User's browser or device. Upon the User's initial visit to the Website, a Cookie Consent Banner will be displayed to inform the User about the use of cookies. Continued use of the Website constitutes acceptance of the practices described herein.

1. Definition of Cookies

Cookies are small text files stored on the User's computer or other device upon access to the Website.

Cookies allow the Company to:

- Recognize the User's device and ensure proper functioning of the Website;
- Personalize the User's experience;
- Collect statistical information for security, usability, and marketing purposes.

The Company utilizes both first-party cookies (set by the Company) and third-party cookies (set by third parties such as analytics and advertising partners).

Cookies can be categorized as:

- **Session Cookies** which expire upon closing the browser;
- **Persistent Cookies** which remain on the User's device for a pre-defined period.

2. Types of Cookies in Use

The Company uses the following categories of cookies on the Website:

Type of Cookie	Purpose	Consent Required?
Necessary Cookies	Essential for core Website functions such as security, navigation, and User authentication. Without these cookies, the Website may not operate correctly.	No (exempt under PECR)
Preference/Functional Cookies	Enable the Website to remember choices made by the User (e.g., language, region, interface settings).	Yes
Analytics/Performance Cookies	Collect anonymized data on Website usage and User interactions to improve performance and user experience.	Yes
Targeting/Marketing Cookies	Track the User's activity across websites to deliver personalized advertising. Often deployed by third-party services.	Yes

The use of third-party cookies is governed by the privacy policies of the respective third-party providers. The User is encouraged to review those policies independently.

3. Managing Cookies

The User may manage or restrict the use of cookies in the following ways:

- By adjusting preferences via the Cookie Consent Banner presented upon first access;
- Through browser settings to block or delete cookies;
- At any time by manually clearing cookies from the User's device.

The User should note that disabling certain types of cookies may impair the functionality of the Website or reduce the quality of the browsing experience.
